## 9. Event Policies

For vendor events and workshops:

- Vendors are responsible for setup and cleanup of their area.
- Vendors must behave professionally toward attendees and other businesses.
- Sacred Roots reserves the right to remove vendors engaging in disruptive or unsafe behavior.
- Event times, setup instructions, and venue rules must be followed.

Sacred Roots reserves the right to cancel or reschedule events due to:

- Weather
- Venue issues
- Emergencies
- Safety concerns
- Low attendance

If Sacred Roots cancels an event, a credit or rescheduled opportunity may be offered.

## 10. Cancellation Policy

### Monthly Partnerships

Monthly partnerships may be canceled with a 30 day written notice.

## Event Partnerships

- Cancellations more than 30 days before an event may qualify for a transferable credit for another event.
  - Cancellations less than 14 days before an event are non-refundable.

## Contract Term & Early Termination Clause

This Agreement shall remain active for a period of one (1) full calendar year beginning on the Effective Date listed within this contract unless otherwise terminated in writing by Sacred Roots Wellness & Resource Center LLC. By signing this Agreement, the Partner acknowledges and agrees to fulfill the financial obligations associated with the selected partnership package for the full one-year term.

In the event the Partner chooses to terminate, cancel, withdraw from, or otherwise break this Agreement prior to the completion of the one-year term, the Partner agrees to remain financially responsible for all remaining monthly payments owed under the Agreement. The remaining balance for the unused months of the contract shall become immediately due unless otherwise agreed upon in writing by Sacred Roots Wellness & Resource Center LLC.

Sacred Roots Wellness & Resource Center LLC reserves the right to pursue collection of unpaid balances resulting from early termination of the Agreement.
